Any extra work to be performed will be charged extra.
3. Any work done by the suggested vendor of the customer will attract additional management charge as mutually agreed.
4. Exact time for food and beverages needs to be provided by the customer as prepared food shall be consumed within 2 hours of preparation after which the quality or taste of food may deteriorate.
5. All paperwork and fees required for the government permissions shall be provided by the customer and the terms and conditions of the permission shall be abided by the customer. Ur Eventz will be totally indemnified by the customer for any breach. Permissions, if any, are denied by the government, then the event shall be postponed or cancelled and would attract penalty as per cancellation terms.
6. Any mishap, damages, injuries, etc. due to performances or fireworks or any other reason shall be the sole responsibility of the customer. Risk for any loss of life or property due to any reason shall be the sole responsibility of the customer. Ur Eventz will be totally indemnified by the customer.
7. Act of God: Ur Eventz will not be held responsible for any delay or cancellation of whole or part event due to natural causes and acts of God.
8. Cancellation of Event: One alternate date subject to availability will be provided if intimation given before 15 days of the event. However, no alternate arrangement will be given and total payment made shall be forfeited for any event cancelled within 72 hours before the start of the event.
9. Payment Terms:
 - a. 10 % - At the time of booking
 - b. 50 % - Within 15 days of booking
 - c. 20 % - Before 15 days of the event
 - d. 20 % - 48 hours before start of the event
 - e. Extra work – Same day on completion of the eventNon payment as per the above terms shall lead to cancellation of the event.
